TERMS AND CONDITIONS: Shop.Play.Win!

1. The **Shop.Play.Win! competition (“the/this Competition”)** is run on **Liberty Midlands Mall** (the “Promoter’s”) Social Media pages (Facebook, Instagram, Twitter) and in Liberty Midlands Mall, and will take place from **31st August – 6th October 2024 and closing on the 6th October 2024 at 15.00 (“the Competition Dates”)**. **Persons entering the Competition will stand a chance to win one of 3 R5000 Liberty Midlands Mall gift cards. There will also be a weekly social media competition for 6 weeks from 28th August – 2nd September where the online audience could win a R500 Liberty Midlands Mall voucher if they are randomly selected by the social media Team.**

The winners of the 3 x R5000 Liberty Midlands gift cards will be drawn on the 7th October 2024 and will be announced on the Liberty Midlands Mall Social Media platforms thereafter.

2. By entering this Competition, the entrant agrees to be bound by the terms and conditions of the promotional competition.

In order to qualify as an entrant for this Competition, the entrant must live in the Republic of South Africa and reside in Pietermaritzburg and the Midlands, have a valid RSA identity document; cannot be a juristic entity and must be an individual and must provide correct personal details as required. Any entrant not adhering to these rules or providing incorrect information will be disqualified and will not be eligible to win a prize. If you are under 18, you have to be accompanied by an adult to in order to claim your prize.
